Priority Permitting

- For multifamily projects that are enrolled in eligible green building certification programs, per the City's Priority Review Policy.

Building Height and Density Bonus

- Density bonus for Planned Residential Development District (PRD) with green building certification.
- Floor Area Ratio (FAR) bonus for downtown district buildings that incorporate landscaping or vegetated roofs or retention of historic structures.
- Height bonus for mixed-use districts for stormwater management, vegetated roofs, solar energy collection and energy efficiency.
- Height bonus for retention or substantial renovation of landmark adjacent to new construction; landmark designation; or historic façade retention.
- Height bonus for mixed-use districts that include parking within building footprint.

Historic Preservation

- Additional development potential allowed (i.e. greater building height, etc.) for buyer through “Transfer of Development Rights” – allows designated Tacoma Landmarks to transfer their development rights for monetary gain or other financial considerations.
- Gap financing of \$20,000-\$100,000 provided through Historic Rehabilitation and Repair Loan Program – designed to encourage the rehab, preservation and adaptive reuse of commercial and retail buildings listed on the Tacoma Register of Historic Places.
- Reduced property taxes for 10 years through Special Tax Valuation – property owners who complete a substantial rehabilitation with two years may benefit.

Water Conservation Incentives

- Rebates for WaterSense-labeled smart irrigation controllers.
- Free business water audit.
- Custom incentives for water-saving upgrades that can offset up to 50% of the initial costs of the hardware and equipment for both commercial and industrial businesses.

Food Waste Recycling

- Weekly collection of all solid food (raw or uncooked), including produce, deli, bakery goods, meats and seafood available at \$16/month (compared to \$56.90/month for garbage).
- Processed through the City's wastewater system where it becomes renewable natural gas (RNG) for heating and TAGRO (soil amendment).

General Recycling

- Multi-family property mixed recycling and commingle cardboard curbside recycling available;
- Commercial commingle cardboard curbside recycling available.

Commercial Sewer Conservation Loan

- Low-interest loans of \$10,000-\$100,000 (up to 90% of the total estimated costs) for existing businesses that install equipment (industrial pre-treatment equipment, grease interceptors, oil/water separators, etc.) to keep pollutants out of the sewer system.

Surface Water/Stormwater

- Flow control credit for retained and newly planted trees may be granted. Tree species, size, location and maintenance requirements must be followed and can be found in the City's Stormwater Management Manual, Chapter 5.

- Reimbursable awards of up to \$4,000 for projects that provide a stormwater benefit focused on stormwater pollution prevention or surface water protection through "Make a Splash" funding.

- Funding assistance for electric vehicle charging stations through Tacoma Public Utilities.

- Parking quantity reductions may be granted for:
 - Transit access.
 - Trip reduction plan.
 - Car sharing.
 - Mixed-use/shared parking.
 - On-street parking.
 - Bicycle parking.
 - Motorcycle/scooter parking.
- Parking lot distribution requirements may be more flexible for:
 - Tree retention.
 - Evergreen tree planting.
 - Low Impact Development techniques (as defined by the City's Stormwater Management Manual) as primary stormwater management approach.
