



## Owner's Authorization Form

<p><b>ABOUT THIS FORM</b></p> <p>An owner authorization form must be completed with most permit applications.</p> <p>The form verifies that the applicant has the authority to apply for permits on and grant access to the subject property. The form also identifies whom to contact in the case of questions, corrections, and issues with the permit application.</p> <p>The assignment of authority is someone you designate as your representative or agent on this application. They will be the contact person for the City and is authorized to make decisions related to the processing of the application as well as coordinate inspections.
